Our Payment portal company, "Stripe"	To process payments	Information needed including card or bank details to process payments
IT service partners e.g. eBaoTech, Hexaware Technologies, Amazon Web Services	Providing secure platforms and hosting of virtual servers	Information necessary to create your policy and if necessary any data relevant to processing a claim (e.g. name, date of birth, contact details, occupation, choice of cover)

- To enable us to provide our services to you, in some circumstances we may transfer your Personal Data outside of the UK, such as the Europe or the United States of America. We have put in place appropriate safeguards to ensure that your Personal Data is protected.
